2. One third of the total due must be paid with this contract by the January meeting, or the slip will be considered vacant. (If consideration is needed the Board must be notified in writing). A vacant slip will be offered to other interested members in order of seniority. (Size of the vessel and space available must be considered, when assigning a vessel. The decision will be the responsibility of the Fleet Capt.) If no other member wants the slip it will be available to new members. The Fleet Captain will use size and available space as the criteria for accepting and assigning the vessel.
3. Payment for the season is due in full on or before April 1, for existing members and upon signature of this agreement for new members.
4. Slip space is only for the member's use and may not be transferred. All boats must be properly registered or documented.
5. Members are encouraged to carry their own insurance. Williamsburgh Yacht Club assumes no liability, expressed or implied, in this regard.
6. Members are responsible for the conduct and safety of all guests, which they bring onto CLUB property. The CLUB reserves the right to ask that the Member escort any guest from the CLUB property when such person is conducting himself/herself in a manner- deemed to be inappropriate or- unsafe.
7. Members are not permitted to install or attach any item(s) to the piles, fingers, piers or docks without the prior permission of the Board of Directors.
8. Dock lines and the method of securing the boat in the slip will be inspected by the Fleet Captain. Members will be advised to replace unsafe lines and change the method of securing the boat if such is deemed to be unsafe. If not done in a reasonable amount of time corrections will be made and the member assessed the charges for same.
9. All boats must be out of their slips by November 1. Any boats not out by Nov. 1<sup>st</sup>. will be given notice that if they are not out by Nov. 15<sup>th</sup>, the member will loose the slip. Additionally, there will be a charge of \$15.00 per day for every day after the 15<sup>th</sup> until it is removed. If the Boat has to be professionally removed and stored the boat owner will be charged the going rate, unless an application for in water winter storage has been accepted and payment for same has been made.
10. A copy of the complete slip rules is available in the By-Laws Book as part of the standing rules.
11. My signature acknowledges that I have read and agree to abide by all Club rules pertaining to slip usage.
12. Jet skis will be considered a separate category. They will be stored in a space specifically for that purpose only. All payments for Jet Skies must be made and all membership fees must be up to date, before the Jet Skies are berthed at the Club.
13. Tenders will not be charged for storage on a float, specified for that purpose. Tenders may be up to 10ft. in length.
